### I. <u>Definition of recognition of CPD/CME activities</u>

CPD/CME activities get recognised when the standard pathway of EACCME® accreditation is not followed but the activity has widely recognised educational and/or CPD value (i.e. publication in a peer review journal with an established and recognized editorial process) and the medical specialist has decided to obtain CPD/CME credits for an activity that has been certified for high quality in a process other than CPD/CME accreditation (i.e. peer review of an article, acceptance of the lecture/paper for presentation at an accredited CPD/CME event etc.).

The EACCME® recognises the following activities:

- Reviewing scientific and educational material (REV)
- Publishing scientific and educational material (PUB)
- Learning by Teaching (LbT)
- Examiner in a UEMS exam

### II. Reviewing scientific and educational material (REV)

#### **Scope of recognition:**

**Reviewing scientific and educational material (REV)** - activities performed within the scope of editorial procedures for journals indexed in PubMed.

#### Reviewing process:

Applications must be submitted on the EACCME® website www.eaccme.eu.

The reviewing process will take two weeks from the date of receipt of the application.

#### Material to be submitted through the EACCME® website:

- Application form with:
  - Name of the article
  - o Name of the journal
  - Impact factor of the journal
  - o Reference in PubMed
  - o Name of the reviewer
  - o Billing information
- Confirmation from the editor of the journal

*Fee*: € 20

#### **Allocation of credits:**

Number of credits for 1 article:

Journal Impact Factor (IF)

None = 1 credit

up to 3 = 3 credits

up to 6 = 6 credits

more than 6 = 10 credits

### III. Publishing scientific and educational material (PUB):

#### **Scope of recognition:**

**Publishing scientific and educational material (PUB)** - authoring publications in journals indexed in PubMed.

#### **Reviewing process:**

Applications must be submitted on the EACCME® website www.eaccme.eu.

All authors of a published article can apply.

The reviewing process will take two weeks from the date of receipt of the application.

#### Material to be submitted through the EACCME® website:

- Application form with:
  - o Name of the article
  - o Name of the journal
  - o Impact factor of the journal
  - o Reference in PubMed
  - o Name of the author
  - Billing information
- Copy of the article

*Fee*: € 20

#### **Allocation of credits:**

Number of credits for 1 article:

Journal Impact Factor (IF)	Credits for 1 <sup>st</sup> Author	Credits for all Other Authors
None	= 2 credits	= 1 credit
up to 3	= 4 credits	= 2 credits
up to 6	= 8 credits	= 4 credits
more than 6	= 12 credits	= 6 credits

### IV. <u>Learning by Teaching (LbT):</u>

#### **Scope of recognition:**

**Learning by Teaching (LbT)** – faculty presentation/participation during the main scientific programme of an EACCME® accredited event.

Eg. lecture, participation in panel discussion, chair or coordinator of session, oral presentation.

Posters will not be considered for accreditation.

#### **Reviewing process:**

Applications must be submitted on the EACCME® website www.eaccme.eu.

The reviewing process will take two weeks from the date of receipt of the application.

#### Material to be submitted through the EACCME® website:

- Application form with:
  - Name of the presentation
  - Name of the EACCME® accredited event
  - o Name of the faculty member
  - Billing information
- Proof from the final programme that the presentation took place

*Fee:* € 20

#### **Allocation of credits:**

1 presentation = 1 credit

#### V. Examiner in a UEMS Exam:

#### **Scope of recognition:**

**Examiner in a UEMS exam** - examiner taking part in an examination organised by a UEMS Section.

#### **Reviewing process:**

Applications must be submitted on the EACCME® website www.eaccme.eu

The reviewing process will take two weeks from the date of receipt of the application.

#### Material to be submitted through the EACCME® website:

- Application form with:
  - o Name of the examination
  - o Date of the examination
  - Venue of the examination
  - Name of the examiner

Fee: Free of charge

#### **Allocation of credits:**

2 credits per examination
