Transfer of application:

If you cannot attend the FEBNM 2026 exam due to unforeseen circumstances, we can give you the option to transfer your application to the FEBNM 2027 Exam.

This option is only possible until up to 2 months before the exam takes place - August 21, 2026. After that day, a transfer to next year's exam is only possible if an additional fee of €100,- is paid.
